


BlueStar® Connective Technologies Index

Key Features



Size and Liquidity Requirements

Full MCap of at least 150 mln USD. Three month average-daily-trading volume of at least 1 mln USD at a review and also at the previous two reviews. At least 250,000 shares traded per month over the last six months at a review and also at the previous two reviews.

Universe

Companies have to generate at least 50% of their revenues from business activity, products, or services designed to facilitate the roll-out of or meet 5G, or 6G technology standards, and other connective technologies.

Diversification

Company weightings are capped at 5%.

Review

Semi-annual in March and September.







